# **Safeguarding and Child Protection**

This role is a tutoring role involving extensive, unsupervised 1-to-1 contact and responsibility for children.

Wavelength Tuition is committed to safeguarding and promoting the welfare of children and young people and expects all tutors, staff and volunteers to share this commitment. The successful applicant will be expected to uphold this duty and be responsible for promoting and safeguarding the welfare of children and young persons for whom they are responsible, or with whom they come into contact, and so to adhere to and ensure compliance with Wavelength Tuition's Safeguarding Policy at all times and complete appropriate training. If in the course of carrying out the duties of the post the post-holder becomes aware of any actual or potential risks to the safety or welfare of children, they must report any concerns to Wavelength Tuition.

Applicants will be required to undergo child protection screening appropriate to the post. Since this role involves 'regulated activity' with children, the successful applicant will be required to complete a Disclosure and Barring Service (DBS) disclosure application. Appointment will be conditional upon Wavelength Tuition being satisfied with the result of the Enhanced DBS check and the outcome of all the other checks.

Wavelength Tuition will also carry out a check of the Children's Barred List on the successful applicant. Applicants should be aware that it is unlawful for Wavelength Tuition to contract anyone to work with children if they are barred from doing so, and it is a criminal offence for a person to apply to work with children if they are barred from doing so. This role is also exempt from the Rehabilitation of Offenders Act 1974 and Wavelength Tuition is therefore permitted to ask shortlisted applicants to declare all convictions and cautions (including those which are 'spent' unless they are 'protected' under the DBS filtering rules) in order to assess their suitability to work with children.
